FAMI works to achieve these goals through the activities of its Intellectual Property Rights Task Force (IPRTF), which include introducing measures to prevent the sales of counterfeit products, conducting consumer awareness campaigns, and lobbying governments on this issue.

- Concerned with the risks posed by counterfeit motorcycles in Asian markets, FAMI established its **Intellectual Property Rights Task Force (IPRTF)** to proactively support the intellectual property activities of industry groups in individual countries.
- FAMI's IPRTF drafts and promotes action plans aimed at raising awareness regarding intellectual property rights/protection and the conduct of dedicated public relations activities.

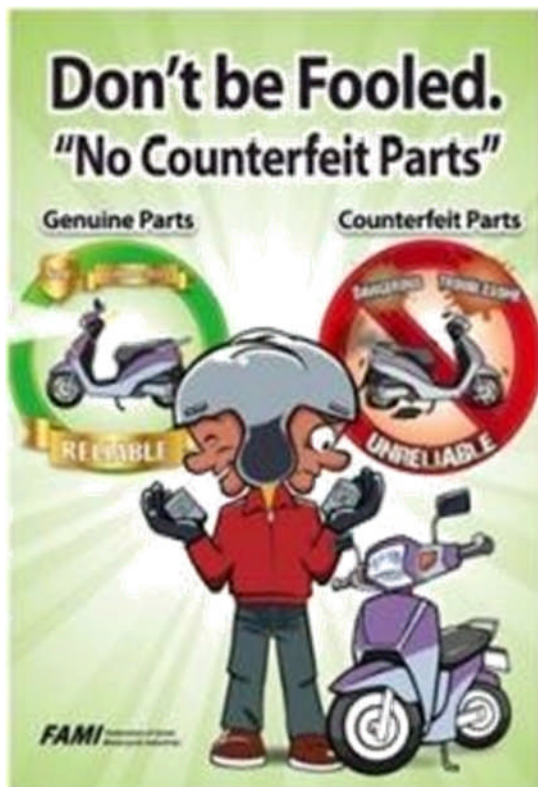
